SPAMF is inter alia established as a Trust incorporated under the Bombay Public Trust Act 1950 & Registration No.E-28570-Mumbal it is the pioneering ventures endeavors to train the students in Computer Literacy and skill development courses and provide health related services at remote areas of states like Maharashtra, thereby making their students to be industry-ready.

Now, we are proposing a project to establish and maintain skill development programs that is Fashion Designing in the village "Arjuni/mor. ", an impoverished rural town of several thousand people in the district of Gondia, with a carefully constructed and sustainable program, for talented andambitious students can have opportunities for work and higher education. The core objective of SPAMF is to train such members of the society, to develop and maintain an essential world class educational facilities related curriculum and content in close association with various courses, which would be made available at base location for the students. On the earnest request of Shri Durga Shikshan Sanstha's-vide letter no ----date ------the SPAMF agreeable to enter into MOU with Shri Durga Shikshan Sanstha's to set up Fashion Designing Course along with Rashtrasant Tukdoji Maharaj Nagpur Universitywith credit base system, as per the terms and conditions set out hereunder:

- 1. Now this MOU is witness as under
- 1.1 Shri Durga Shikshan Sanstha's, School/trust/society-hereby agrees to allow SPAMF to set up a Fashion Designing Lab within the premises Shivprasad Sadanand Jaiswal College, Arjuni/mor. This college is solely run and controlled by Shri Durga Shikshan Sanstha's.
- 1.2 SPAMF and Shri Durga Shikshan Sanstha's, School/trust/society-would collaborate to implement the Fashion Designing course training(or as the case may be) designed by Rashtrasant Tukdoji Maharaj Nagpur University with credit base system, for the minimum 400-500 of students of Shivprasad Sadanand Jaiswal College, Arjuni/mor.
- 2. Role of SPAMF.
- 2.1 SPAMF will undertake the following activities at the school as per its internal guidelines
- 2.1.1 Set up a well-equipped Fashion Designing lab
- 2.1.2 Recruit a qualified Trainer & ensure their training
- 2.1.3 Bear following expenses only & ensure as under
  - 2.1.3.1 Provide Sewing Machines with maintenance
  - 2.1.3.2 Procure requisite software for training
  - 2.1.3.3 Basic Material for the Training Purpose
  - 2.1.3.4 Provide this training facility free of cost to students, Community only, along with course
  - 2.1.3.5 Pay Trainer salary appointed by SPAMF as per sole discretion of SPAMF
- 2.1.4 Monitor progress through Team Leader, Master trainer and/or Head of Education visits to college, as
- 2.1.5 Issue certificates after course completion to all students as per their course level
- 2.1.6 Provide a Refresher training for interested School Teachers. This activity schedule will be decided mutually as per the suitable time between SPAMF & School 2.5 Procedure for appointment of Trainer may be discussed with school and/or Headmaster, if required
- 2.1.7 All activities will be done by SPAMF in all schools & for all students on a permanent basis. We also Encourage & Participated in Massive Plantation in all schools
- 3. Role of " Shri Durga Shikshan Sanstha's, Arjuni/mor " School/trust/society,
- 3.1 The College shall ensure to provide following things within its premises
  - 3.1.1 Appropriate, properly waterproof & secure space to set up Fashion Designing lab as per Specifications of SPAMF
  - 3.1.2 Class room should be well-ventilated & designed to allow a good inflow of natural air& light
  - 3.1.3 Color the room as per the color scheme provided by SPAMF
  - 3.1.4 Install all windows with proper locks & metal/steel grills
  - 3.1.5 Provide extra safety gate at entrance door of lab
  - 3.1.6 Complete safety & security of the equipment provided
  - 3.1.7 Provide uninterrupted electric supply & ample switchboard
  - 3.1.8 Pay regular electricity bill

- 3.1.9 Ensure daily housekeeping & cleaning of the lab
- 3.1.10 Repair/paint the classroom for natural wear & tear as decided in joint meeting between SPAMF & Institute
- 3.2 College shall strictly follow the Fashion Designing course time table and send students for the course.
- 3.3 Daily, weeklyonce or twice or as per decided schedule, each student must be Allotted 1-hour continuous or 2-consecutive periods to learn Fashion designing for 120 hours.
- 3.4 Nominate college teachers for attending the beginner, refresher training.
- 3.5 Not interfering in the management of facilities provided by SPAMF
- 3.6 Not use any equipment provided by SPAMF for their personal use
- 3.7 Be responsible & accountable for any equipment misplaced or damaged by them, but we will discuss it first mutually and then we will take decision.
- 3.8 Allow SPAMF to put the name stone or board outside the Fashion Designing lab.
- 3.9 Allow SPAMF board or stone for showing direction/information on the main road, that will be included \ names of SPAMF,RTMN University & College.
- 3.10 All equipment, machines, software& furniture installed in the Fashion Designing lab shall be sole property of SPAMF and SPAMF reserves the right to revoke or alter the facility & itsequipment at any point of time in future, when it will be unutilized or no response for course. SPAMF reserves the right to remove the equipment provided at any time at its own discretion.
- 3.11 Allow outside students and Community in campus for learning in Lab.
- 3.12 If Institute management insists the foundation to close the Fashion Designing Lab or closes the Suo moto set up by the foundation's expenses, prior to 5 years or during the validity of this Mou, the College management shall be bound to repay the infrastructure and installation cost incurred in this tab to foundation amounting roughly, of Rs 40,000/- prior to such closure.
- 3.13 If college or school management has set up their own lab then Foundation shall withdraw lab to avoid duplication of activity.
